COUNT I: MISCONDUCT IN PUBLIC OFFICE

On or about April 12, 2018, on Saipan, Commonwealth of the Northern Mariana Islands, the Defendant, **Ralph Anthony Deleon Guerrero Torres**, while being Governor of the Commonwealth of the Northern Mariana Islands, and an employee of the Commonwealth government, did an illegal act under color of office, to wit: he violated 1 CMC § 7407(f) in that he caused to be issued airline tickets for business class, first class, or other premium class travel for himself using Commonwealth funds, in violation of and made punishable by 6 CMC § 3202.

COUNT II: MISCONDUCT IN PUBLIC OFFICE

On or about April 12, 2018, on Saipan, Commonwealth of the Northern Mariana Islands, the Defendant, **Ralph Anthony Deleon Guerrero Torres**, while being Governor of the Commonwealth of the Northern Mariana Islands, and an employee of the Commonwealth government, did an illegal act under color of office, to wit: he violated 1 CMC § 7407(f) in that he caused to be issued airline tickets for business class, first class, or other premium class travel for Diann T. Torres using Commonwealth funds, in violation of and made punishable by 6 CMC § 3202.

COUNT III: MISCONDUCT IN PUBLIC OFFICE

On or about June 8, 2018, on Saipan, Commonwealth of the Northern Mariana Islands, the Defendant, **Ralph Anthony Deleon Guerrero Torres**, while being Governor of the Commonwealth of the Northern Mariana Islands, and an employee of the Commonwealth government, did an illegal act under color of office, to wit: he violated 1 CMC § 7407(f) in that he caused to be issued airline tickets for business class, first class, or other premium class travel for himself using Commonwealth funds, in violation of and made punishable by 6 CMC § 3202.

COUNT IV: MISCONDUCT IN PUBLIC OFFICE

On or about July 11, 2018, on Saipan, Commonwealth of the Northern Mariana Islands, the Defendant, **Ralph Anthony Deleon Guerrero Torres**, while being Governor of the Commonwealth of the Northern Mariana Islands, and an employee of the Commonwealth government, did an illegal act under color of office, to wit: he violated 1 CMC § 7407(f) in that he caused to be issued airline tickets for business class, first class, or other premium class travel for himself using Commonwealth funds, in violation of and made punishable by 6 CMC § 3202.

COUNT V: MISCONDUCT IN PUBLIC OFFICE

On or about July 11, 2018, on Saipan, Commonwealth of the Northern Mariana Islands, the Defendant, **Ralph Anthony Deleon Guerrero Torres**, while being Governor of the Commonwealth of the Northern Mariana Islands, and an employee of the Commonwealth government, did an illegal act under color of office, to wit: he violated 1 CMC § 7407(f) in that he caused to be issued airline tickets for business class, first class, or other premium class travel for Diann T. Torres using Commonwealth funds, in violation of and made punishable by 6 CMC § 3202.

COUNT VI: MISCONDUCT IN PUBLIC OFFICE

On or about August 13, 2018, on Saipan, Commonwealth of the Northern Mariana Islands, the Defendant, **Ralph Anthony Deleon Guerrero Torres**, while being Governor of the Commonwealth of the Northern Mariana Islands, and an employee of the Commonwealth government, did an illegal act under color of office, to wit: he violated 1 CMC § 7407(f) in that he caused to be issued airline tickets for business class, first class, or other premium class travel for himself using Commonwealth funds, in violation of and made punishable by 6 CMC § 3202.

COUNT VII: MISCONDUCT IN PUBLIC OFFICE

On or about August 16, 2018, on Saipan, Commonwealth of the Northern Mariana Islands, the Defendant, **Ralph Anthony Deleon Guerrero Torres**, while being Governor of the Commonwealth of the Northern Mariana Islands, and an employee of the Commonwealth government, did an illegal act under color of office, to wit: he violated 1 CMC § 7407(f) in that he caused to be issued airline tickets for business class, first class, or other premium class travel for Diann T. Torres using Commonwealth funds, in violation of and made punishable by 6 CMC § 3202.

COUNT VIII: MISCONDUCT IN PUBLIC OFFICE

On or about September 25, 2018, on Saipan, Commonwealth of the Northern Mariana Islands, the Defendant, **Ralph Anthony Deleon Guerrero Torres**, while being Governor of the Commonwealth of the Northern Mariana Islands, and an employee of the Commonwealth government, did an illegal act under color of office, to wit: he violated 1 CMC § 7407(f) in that he caused to be issued airline tickets for business class, first class, or other premium class travel for himself using Commonwealth funds, in violation of and made punishable by 6 CMC § 3202.

COUNT IX: MISCONDUCT IN PUBLIC OFFICE

On or about November 15, 2018, on Saipan, Commonwealth of the Northern Mariana Islands, the Defendant, **Ralph Anthony Deleon Guerrero Torres**, while being Governor of the Commonwealth of the Northern Mariana Islands, and an employee of the Commonwealth government, did an illegal act under color of office, to wit: he violated 1 CMC § 7407(f) in that he caused to be issued airline tickets for business class, first class, or other premium class travel for himself using Commonwealth funds, in violation of and made punishable by 6 CMC § 3202.

COUNT X: MISCONDUCT IN PUBLIC OFFICE

On or about November 27, 2018, on Saipan, Commonwealth of the Northern Mariana Islands, the Defendant, **Ralph Anthony Deleon Guerrero Torres**, while being Governor of the Commonwealth of the Northern Mariana Islands, and an employee of the Commonwealth government, did an illegal act under color of office, to wit: he violated 1 CMC § 7407(f) in that he caused to be issued airline tickets for business class, first class, or other premium class travel for himself using Commonwealth funds, in violation of and made punishable by 6 CMC § 3202.

1 **COUNT XI: MISCONDUCT IN PUBLIC OFFICE**

2 On or about November 27, 2018, on Saipan, Commonwealth of the Northern Mariana Islands,
3 the Defendant, **Ralph Anthony Deleon Guerrero Torres**, while being Governor of the Commonwealth
4 of the Northern Mariana Islands, and an employee of the Commonwealth government, did an illegal act
5 under color of office, to wit: he violated 1 CMC § 7407(f) in that he caused to be issued airline tickets
6 for business class, first class, or other premium class travel for Diann T. Torres using Commonwealth
7 funds, in violation of and made punishable by 6 CMC § 3202.

8 **COUNT XII: MISCONDUCT IN PUBLIC OFFICE**

9 On or about December 17, 2018, on Saipan, Commonwealth of the Northern Mariana Islands,
10 the Defendant, **Ralph Anthony Deleon Guerrero Torres**, while being Governor of the Commonwealth
11 of the Northern Mariana Islands, and an employee of the Commonwealth government, did an illegal act
12 under color of office, to wit: he violated 1 CMC § 7407(f) in that he caused to be issued airline tickets
13 for business class, first class, or other premium class travel for himself using Commonwealth funds, in
14 violation of and made punishable by 6 CMC § 3202.

15 **COUNT XIII: THEFT**

16 On or between April 12, 2018 to May 30, 2019, on Saipan, Commonwealth of the Northern
17 Mariana Islands, the Defendant, **Ralph Anthony Deleon Guerrero Torres**, unlawfully took, used, or
18 consumed the property of another with intent to permanently deprive the owner of their rights to the
19 property, with an aggregate amount of \$20,000.00 or more, to wit: Ralph Anthony Deleon Guerrero
20 Torres did unlawfully take Commonwealth property by using Commonwealth funds to pay for first,
21 business, or premium class travel for himself, and for airline tickets for Diann T. Torres, on multiple
22 occasions from April 12, 2018 to May 30, 2019, in violation of 6 CMC § 1601(a) and made punishable
23 by 6 CMC § 1601(b) and (c).

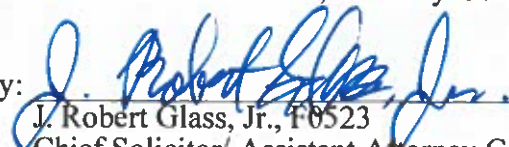
25 **COUNT XIV: CONTEMPT**

26 On or about December 10, 2021, on Saipan, Commonwealth of the Northern Mariana Islands,
27 the Defendant, **Ralph Anthony Deleon Guerrero Torres**, failed to appear in compliance with a
28 subpoena, in violation of 1 CMC § 1306(a)(1) and made punishable by 1 CMC § 1307(a).
